Elektra Natchios' Overcoat and Pair of Stunt Wakizashis

Elektra Natchios' overcoat and a pair of stunt wakizashis from Season 1 of Marvel's The Defenders. Resurrected by the criminal organization known as The Hand, Natchios hunts The Defenders throughout the season. This lot consists of a black cotton and silk blend overcoat with a zippered, removable hood and a burgundy interior labeled 'Elektra' and a pair of urethane swords with black tape on the grips. The lot is in good overall condition with several holes in the coat and a tip broken off one sword.

Estimate: \$2,000 - 3,000



Elektra Natchios' Metal Sais

Elektra Natchios' metal sais from the episode 'Worst Behavior' (103) of Marvel's The Defenders. In the episode, Elektra Natchios chooses her signature sais from a rack of The Hand's weapons presented to her by Alexandra Reid. This pair of steel sais with white and black nylon handles is in excellent overall condition with minor signs of use to each from production.

Estimate: \$3,000 - 5,000



Dead Chaste Ninja's Katana

A dead Chaste ninja's katana from the episode 'Mean Right Hook' (102) of Marvel's The Defenders. In the episode, Danny Rand and Colleen Wing discover a group of The Chaste's ninjas dead with their katanas beside them. This metal katana with a green and white handle is in good overall condition with minor signs of use, including chipping on the guard.

Estimate: \$600 - 800



Matt Murdock's Red Daredevil Cowl

Matt Murdock's red Daredevil cowl from the episode 'Fish in the Jailhouse' (107) of Marvel's The Defenders. In the episode, Franklin 'Foggy' Nelson gives Murdock his signature Daredevil costume and mask while Murdock is detained at a police station. This plated resin cowl is painted in Daredevil's signature red with black and silver details, clear red plastic lenses, and black tape coating the interior. As it was not designed as a costume component, it is smaller than the cowls made for the full Daredevil

costume and therefore not intended to be worn. The cowl is in fair overall condition with visible signs of wear from production, including cracked plating at the top and base of the neck, as well as scuffed paint throughout.

Luke Cage's Post-Royal Dragon Fight Costume

Luke Cage's post-Royal Dragon fight costume from the episode 'Take Shelter' (105) of Marvel's The Defenders. In the episode, Cage wears his costume when he emerges from the fight at the Royal Dragon with a prisoner. This lot consists of a charcoal cotton and polyester zip-up hoodie with yellow lining, a yellow cotton and polyester shirt, a pair of dark blue jeans, and a pair of sneakers. The lot is in good overall condition with extensive intentional distressing throughout from production.

Danny Rand's Defenders Costume

Danny Rand's Defenders costume from Season 1 of Marvel's The Defenders. Rand wears his costume throughout the season as one of The Defenders to protect New York City from The Hand. This lot consists of a pine green cotton and polyester blend jacket, a green cotton sweatshirt, a sage green cotton blend shirt, a pair of light gray jeans, and a pair of brown leather and rubber boots. The lot is in excellent overall condition with minor signs of wear from production throughout, including some scuffing on the shoes.

Matt Murdock's Stunt First Iteration Daredevil Costume

Matt Murdock's stunt first iteration Daredevil costume from Seasons 1 and 2 of Marvel's Daredevil. Murdock dons his signature red and black costume and horned cowl as the blind vigilante hero Daredevil throughout both seasons. This lot consists of a flexible urethane stunt cowl with rubber and nylon lining painted in Daredevil's signature red with silver and black ridged details, a matching spandex and polyester blend stunt compression suit, a matching polyester and nylon stunt vest, a pair of plated gray hard resin greaves labeled 'Hero' and 'HERO #2 RIGHT GREIVE (HARD)' [sic], a single black leather and polyester glove, an additional pair of black polyester stunt gloves, and a pair of rubber-soled black stunt sneakers. This lot is in good overall condition with visible signs of wear from production throughout, including cracks on the back of the helmet and on one of the greaves.




Matt Murdock's Stunt Second Iteration Red Daredevil Suit

Matt Murdock's stunt second iteration red Daredevil suit from Season 2 of Marvel's Daredevil and Season 1 of Marvel's The Defenders. Murdock dons his signature red and black costume and horned cowl as the blind vigilante hero Daredevil throughout both seasons. This lot consists of a crimson flexible urethane cowl with black details and mesh eye holes, a matching spandex and polyester blend compression suit, a matching polyester and nylon stunt vest with harness holes on the reverse, a detachable black spandex hood, a black spandex blend zip-up muscle shirt, a pair of segmented rubber and leather gloves with fastening strip closures, a pair of black leather lace-up stunt boots, and a pair of crimson and gunmetal gray foam rubber and metal billy clubs with ridged sides and a rope connecting the clubs end-to-end. This lot is in good overall condition with visible signs of wear from production throughout.



Matt Murdock's Stunt New York Bulletin Costume, Mask, and Scissors

Matt Murdock's stunt New York Bulletin costume, mask, and scissors from the episode 'The Devil You Know' (306) of Marvel's Daredevil. In the episode, Daredevil impersonator Benjamin 'Dex' Poindexter stabs Murdock with a pair of scissors at the New York Bulletin offices. This lot consists of a black polyester zip-up jacket, a white cotton button-up shirt, a pair of charcoal wool slacks, a black leather belt, a pair of black sneakers, a pair of black and red rubber stunt scissors, and a black wool and cotton stunt mask with a resin nose guard. The lot is in excellent overall condition with minor signs of wear from production throughout.

Estimate: \$1,500 - 2,500



Matt Murdock's Stunt Vigilante Sweater and Muay Thai Rope Gloves

Matt Murdock's stunt vigilante sweater and Muay Thai rope gloves from Season 3 of Marvel's Daredevil. Throughout the season, Murdock wears his sweater and gloves with Muay Thai rope wraps while he patrols Hell's Kitchen as masked vigilante Daredevil. This lot consists of a charcoal cotton sweater affixed with a crimson neckline, nylon liners inside the sleeves, and fastening strip

closures on the wrists, as well as two elastic and cotton gloves fitted with blood-stained rope hand wraps, cloth tassels, and fastening strips. The lot is in good overall condition with wear from production throughout.

Elektra Natchios' Hangar Costume and Sais

Elektra Natchios' hangar fight costume and sais from the episode 'The Man in the Box' (210) of Marvel's Daredevil. In the episode, Natchios wears her costume when she fights an assassin out to kill her. This lot consists of an ivory-color cotton and rayon cardigan, a black jacket, a pair of cotton and elastic pants, a pair of black suede shoes, a pair of black rubber sais with white handles and a black leather weapons case with a red felt interior. It is in good overall condition with minor wear from production, including paint chipping on one sai.




Elektra Natchios' Stunt Yakuza Costume

Elektra Natchios' stunt Yakuza costume from the episode 'Semper Fidelis' (207) of Marvel's Daredevil. In the episode, Natchios wears her costume when she and Matt Murdock come upon a tunnel being dug by the Yakuza. This stunt costume consists of a black and red cotton and spandex leotard, black pleated jeans, a black leather and elastic belt, and a pair of black leather sneakers with red heels. It is in good overall condition with minor signs of wear from production throughout.

Wilson Fisk and Vanessa Marianna's Wedding Set

Wilson Fisk's and Vanessa Marianna's wedding set from the episode 'A New Napkin' (313) of Marvel's Daredevil. In the episode, Fisk fights Daredevil immediately after his and Marianna's wedding. This lot consists of a white silk and polyester blend tuxedo jacket labeled 'Bespoken for Wilson Fisk', a white silk vest, a cotton and nylon blend shirt labeled for the actor, a pair of white polyester blend pants, a faux silver engagement ring inset with a faux diamond, a pair of rhodium-plated faux diamond earrings, and a cream-color polyester blend zip-up wedding gown labeled 'Vanessa #1'. The set is in good overall condition with extensive blood stains applied by production to the jacket, pants, vest, and shirt.

Framed and Bloodied 'Rabbit in a Snowstorm' Painting

A framed and bloodied 'Rabbit in a Snowstorm' painting from Season 3 of Marvel's Daredevil. Wilson Fisk's favored painting appears throughout the season after Benjamin 'Dex' Poindexter stains its frame while stealing it from Esther Falb. This wood-framed white painted canvas is in good overall condition with blood stains on the wood from production and minor nicks from handling. This is an oversize lot that requires special shipping.



Jessica Jones' First Leather Jacket Costume

Jessica Jones' first leather jacket costume from the episode 'AKA I Want Your Cray Cray' (207) of Marvel's Jessica Jones. In a flashback within the episode, Stirling Adams encourages Jones to use her powers to steal her first leather jacket. This lot consists of a black leather jacket with metal details, a dark gray and yellow cotton graphic tank top, a pair of distressed blue jeans with white star details, and a pair of black leather stunt boots. It is in excellent overall condition with minor scuffing on the boots.

Oscar Arocho's Color Painting of Jessica Jones Sleeping

Oscar Arocho's color painting of Jessica Jones sleeping from the episode 'AKA Facetime' (206) of Marvel's Jessica Jones. In the episode, Arocho leaves his portrait of Jones outside of her apartment as a gift. This illustration of Jones sleeping is a giclee reproduction of an original mixed media painting by David Mack on canvas stapled to a wood frame. The painting is in good overall condition with some splotching and creasing to the canvas from production.

Oscar Arocho's Sketch of Jessica Jones Sleeping

Oscar Arocho's sketch of Jessica Jones sleeping from the episode 'AKA Facetime' (206) of Marvel's Jessica Jones. In the episode, Arocho sketches Jones in bed after they share an intimate evening together. Using a giclee reproduction of a David Mack original as a base, this incomplete sketch of Jones sleeping is rendered in mixed media on canvas affixed to a wood frame. The sketch is in good overall condition with some discoloration to the edges of the canvas from production.



Kilgrave's Haunting Hallucination Costume

Kilgrave's haunting hallucination costume from the episode 'AKA Three Lives and Counting' (211) of Marvel's Jessica Jones. In the episode, a long-deceased Kilgrave wears his costume when he appears to Jessica Jones as a vision of her self-doubt after she kills another person. This costume consists of a striped blue wool suit jacket and matching pants marked for a photo double, a fret-patterned purple, blue, and gold cotton blend button-up shirt, a striped purple silk pocket square, a purple silk blend tie, a multicolor leather belt with a metal buckle, and a pair of brown leather shoes. The costume is in excellent overall condition with minor signs of wear from production.

Estimate: \$2,000 - 3,000



Luke Cage's Warehouse Explosion Costume Components

Luke Cage's warehouse explosion costume components from the episode 'Soliloquy of Chaos' (112) of Marvel's Luke Cage. In the episode, Cage wears a hoodie given to him by a famous rapper while getting information from Turk Barrett in a warehouse that explodes. This lot consists of a beige and green camouflage-patterned cotton and polyester hoodie and a navy cotton shirt. The lot is in good overall condition with the sweatshirt charred and torn by production to appear burnt.

Hammertech DP-12 Shotgun and Four Judas Bullets

A Hammertech DP-12 shotgun and four Judas bullets from the episodes 'Manifest' (107), 'Blowin' Up the Spot' (108), and 'For Pete's Sake' (209) of Marvel's Luke Cage. In the episodes, Willis 'Diamondback' Stryker loads specialty bullets meant for Luke Cage before showing them off to Mariah Dillard, who later defends herself with a shotgun at Rand Enterprises. This lot consists of four black and gray resin 'Judas' bullets and a black foam rubber shotgun with a pair of grips. The lot is in good overall condition with some paint chipping from production. A blaze orange plug was affixed to the end of the gun after production in order for it to be sold as a collectible.

Estimate: \$1,500 - 2,500



Misty Knight's Hero Cybernetic Arm

Misty Knight's hero cybernetic arm from the episode 'All Souled Out' (205) of Marvel's Luke Cage. In the episode, Rand Enterprises fits Knight with a cybernetic arm after she loses her own human arm to an agent of The Hand. This lot consists of a black, gold, red, and clear plated rubber arm with faux mechanical details, urethane knuckles, a black elastic cloth sleeve, and a custom display stand. The lot is in excellent overall condition with minor signs of wear from production.

Danny Rand's Bloodied Fight for the Iron Fist Costume and Sash

Danny Rand's bloodied fight for the Iron Fist costume and sash from the episode 'The City's Not for Burning' (202) of Marvel's Iron Fist. In the episode, Rand is tethered to Davos while they fight for the title of Iron Fist. This lot consists of a yellow polyester and cotton blend mask with black eyeholes, a blood-stained white cotton gi shirt and pants, a pair of white rubber and leather shoes, and a yellow cotton sash. The lot is in good overall condition with some signs of wear from production throughout.



Davos' Ceremonial Iron Fist Flesh Piece and Accessories

A ceremonial Iron Fist tattoo set from the episode 'Target: Iron Fist' (204) of Marvel's Iron Fist. In the episode, Davos commissions the Crane Sisters to steal the power of the Iron Fist from Danny Rand. This lot consists of a skin-color foam and papier-mache flesh piece marked with the Iron Fist dragon tattoo, a dulled metal paring knife with a curved blade, a rubber ceremonial bowl, and three bronze-color and black polyurethane tattoo needles. The lot is in fair overall condition with burns and stains on the flesh piece, chipped polyurethane, and some warped rubber from production.

Estimate: \$1,000 - 1,500



Danny Rand's Gunslinger Costume

Danny Rand's gunslinger costume from the episode 'A Duel of Iron' (210) of Marvel's Iron Fist. In the episode, Rand wears the costume and gun belt he stole from previous Iron Fist Orson Randall when he confronts Randall's men. This lot consists of a brown leather overcoat, a gray striped cotton dress shirt, a pair of green cotton cargo pants, a brown leather belt marked '1. DR', a pair of brown leather and rubber boots marked '1. DR', and a brown leather and metal gun belt. This costume is an 'Easter Egg' tying the show to the broader Marvel Universe, as Orson Randall was an earlier bearer of the Iron Fist moniker in the comic books. The lot is in good overall condition with the shirt and overcoat intentionally distressed by production to look worn.
