



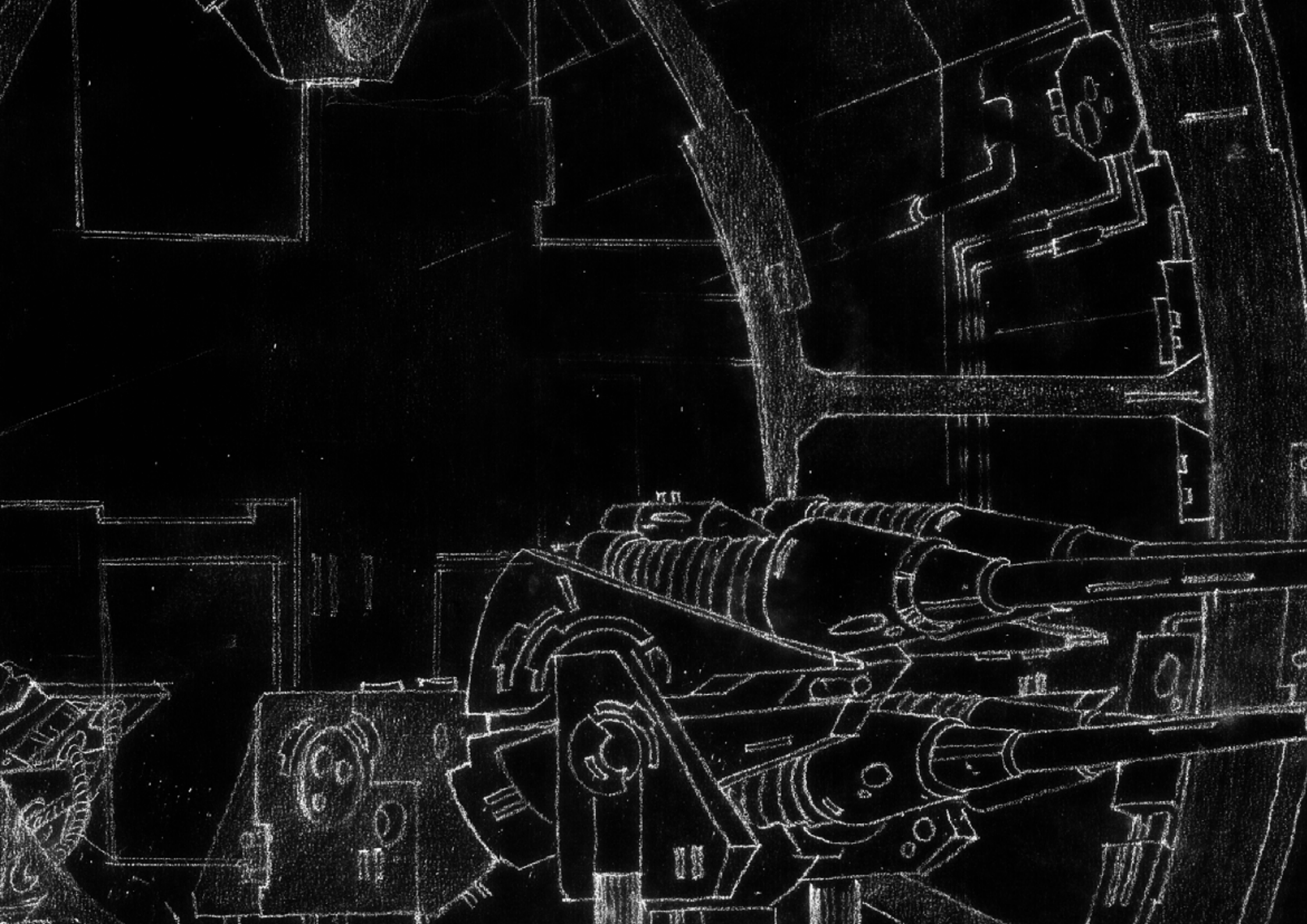

Prop Store Condition Scale

The lots in this auction have been graded by Prop Store using four simple forms of classification as defined below. Please note that in addition to the gradings, Prop Store also provides individual condition details in the online catalogue for each item. Furthermore, we also provide various photographic images of each item in order to properly show any particular condition issues and should a prospective buyer wish to view

anything in person, this can also be arranged by appointment.

Excellent	This describes items which are in excellent to near mint condition with no major faults at all.
Good	This describes items that will have some minor signs of wear/faults but overall remain in good to very good condition.
Fair	This describes items that still present well but which have a number of small faults such as pin-holes, foldline wear, tape stains, minor surface paper loss, marks etc.
Poor	This describes items which have several major flaws which probably require remedial conservation restoration.

Materials and Mediums

Tracing Paper

Tracing Paper is a thin translucent paper used as part of the design process for coping, transferring and tracing images, varying in GSM (grams per square meter) being on average ~90gsm in weight.

Vellum Paper

Vellum Paper is textured, plasticised and made of rag cotton or fibres from interior tree bark, this paper is translucent and is used as part of the design process for coping, transferring and tracing design drawings. Vellum as a material for writing and drawing was traditionally made using animal skin for its toughness and durability.

Card

Card is a stiff thicker paper material made from a cellulose fibre (such as wood pulp). Card also has an increased rigidity and impact resistance. The mounts and frames of lots in this auction are made of card (this type of card is often referred to as paperboard).

Acrylic

Acrylic is often a thick transparent plastic sheet but does come in a range of opacity and rigidity. Acrylic refers the type of synthetic, or man-made, plastic materials containing one or more derivatives of acrylic acid.

Photographic Paper

Photographic paper is a paper coated with a light-sensitive chemical formula, used for making photographic prints. When photographic paper is exposed to light, it captures a latent image that is then developed to form a visible image. Photographic paper has a gloss finish and reflects light well on the photo side and is often matte on the reverse.

Fabric

Fabric refers to a woven cloth of textile fibres.

Paper

Paper is a material manufactured from thin sheets of cellulose pulp of wood or other fibrous substances.

Pencil

A tool used for writing and drawing, consisting of a thin stick of graphite or a similar substance enclosed in a long thin piece of wood or fixed cylindrical case. Pencil as a medium is that may be liable to smudge if pressure is moved across it.

Pen

An instrument for writing or drawing with ink, typically consisting of a metal nib or ball, or a nylon tip, fitted into a metal or plastic holder.

Photograph

An image produced from the process of photography induced by a chemical reaction of light and or other radiant energy. The photographs were produced using photographic paper, resulting in a shiny, gloss on the image side.

Print

An image produced from the process of mechanical transfer of text, images or designs, with ink onto paper.

HARRY LANGE

(1930 - 2008)

HARDWARE WARS - DESIGNS OF THE FUTURE

Harry Lange, art director and set dresser for the original 'Star Wars' trilogy was no stranger to designing the future. As a classically trained artist and designer he spent his formative years designing and visualizing the real thing for NASA. Drafted into the US Airforce in the 1950s he used his artistic skills to draw fighter aircraft, helicopters and ballistic missiles for Red Stone Arsenal the forerunner to NASA.

He joined the newly formed future projects team at NASA and was placed in charge of a group of artists and illustrators who worked with German Rocket scientist Werner von Braun to visualize the future and convince Congress and the public to support the space program. It was while he was creating space stations and rockets that went to the moon that he came into contact with the celebrated science fiction author Arthur C. Clarke. Clarke happened to be working with Stanley Kubrick in New York on the script for '2001: A Space Odyssey'. Harry met Stanley and the rest is history.

Harry moved to England with his family in 1965 and learned the craft of movie design literally on the job. He had never worked on a film before and was thrown into the deep end. Moving from concepts to models to set design over a three and half year production. He received the British Academy Award for Best Art Direction alongside Ernie Archer and Tony Masters and was nominated for an Oscar®. Not bad for your first film! 'Kelly's Heroes' followed and several other films until another fortuitous meeting with 'Star Wars' production designer John Barry at a dinner party. They had worked together

previously on 'Kelly's Heroes'. Harry was brought on initially as a consultant and later as an art director. All of that technical training nurtured at NASA, developed by Kubrick on 2001 and working with a miniscule budget all were to play their part in creating what has become one of the most successful movie franchises. Not that anyone on the crew thought so at the time least of all my Father. Financial necessity was the mother of invention and the idea of recycling junk yard scrap was born. Perhaps the first example of sustainable recycling ever done on a film production. As a young teenager, I vividly remember accompanying my Father with a wheelbarrow and combed the aircraft breakers' yards around Heathrow Airport in the hunt for unusual and interesting scrap metal and components that could be integrated into props and sets. Everything was costed by weight and then transported back to the studio and the process of design would begin. Frequent visits to hardware and plumbing stores were full of intergalactic possibilities. What was different was that everything had to look as if it could really work, it had to have an authenticity and look credible especially in camera close ups. Much of Harry's original designs for the interior for the Millennium Falcon grew out of the objects found. Harry's junkyard fetishism was combined with a strong sense of design that created a kind of symmetrical asymmetry. It was much more than just set-dressing, there was a functional rhythm to the layouts of computer consoles for example created for the Death Star. Amazing what could be achieved with some letterset tape, junk sprayed silver and Perspex buttons, Formica work tops and automobile tail lights. Harry worked alongside Roger Christian who would help to create that messed up look

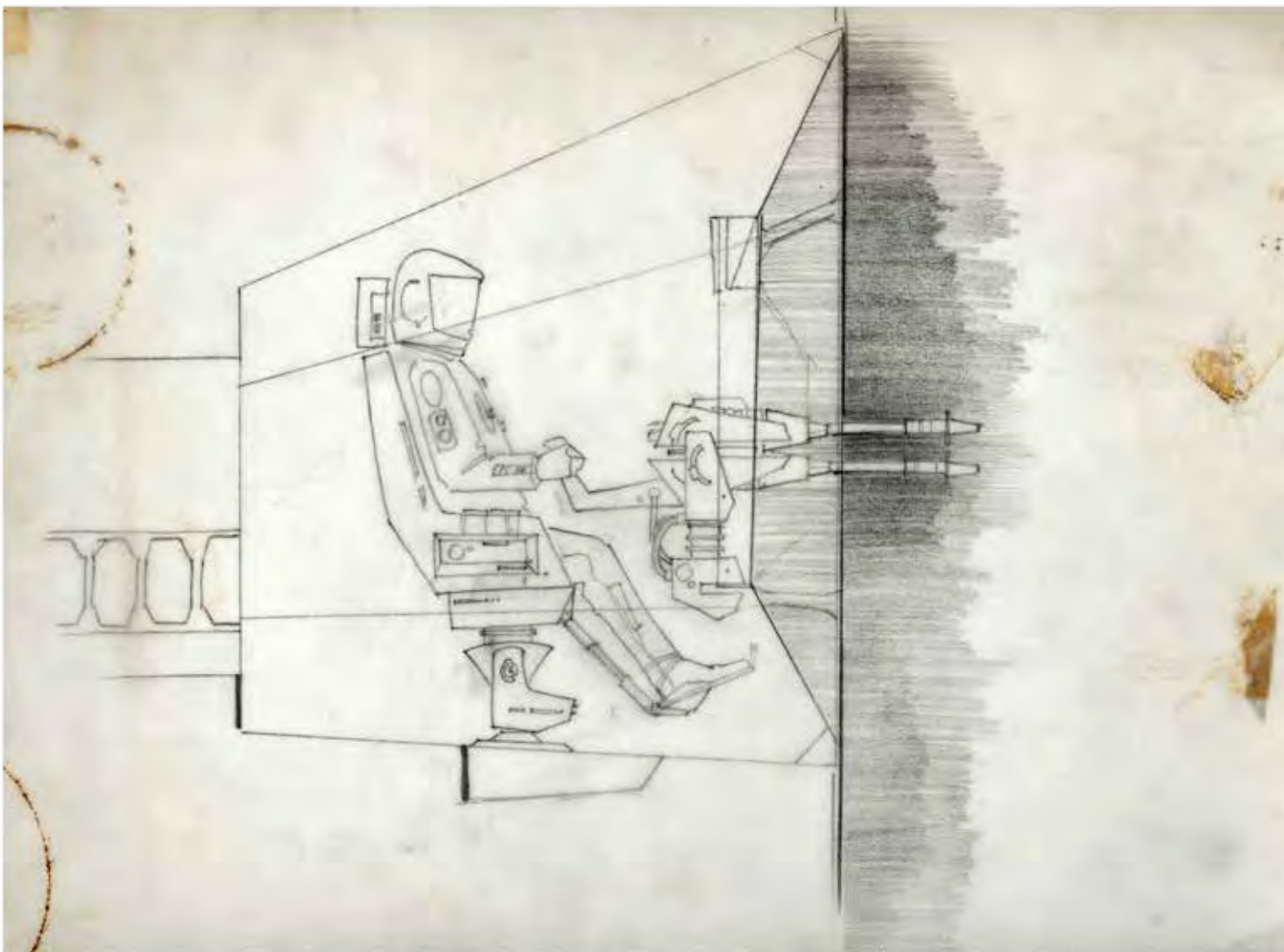
and went on to make some of the movie's most iconic props.

It was that same sense of design that was to inform the production design on the sequel trilogy. A visit to the Prop Shop at Pinewood studios while they were making 'The Force Awakens' brought me face to face with a portfolio of all of my father's designs for the original trilogy. They were using them to create mood boards and to get the next generation design teams to think like Harry. It was very moving moment and felt like my Father was on the production despite having passed away in 2008. As they were re-creating the Millennium Falcon they had to undergo a process of industrial archaeology. This was all vindication and recognition of my Father's contribution to the overall look of the original films.

Harry never received credit for his work on the original 'Star Wars' as he was not a member of the Union and lost out on winning an Oscar as a result. He did go on to become an art director for 'Empire Strikes Back' and was nominated for an Oscar for a second time. His legacy lives on not just in the films he made but also through a bursary at the International Film Design School based at Pinewood Studios. The Harry Lange Bursary was created after his death to help support the training of the next generation of art directors. It is very fitting that one of the recipients of the bursary has gone on to work in the art department for the new Star Wars films. Harry would be pleased.

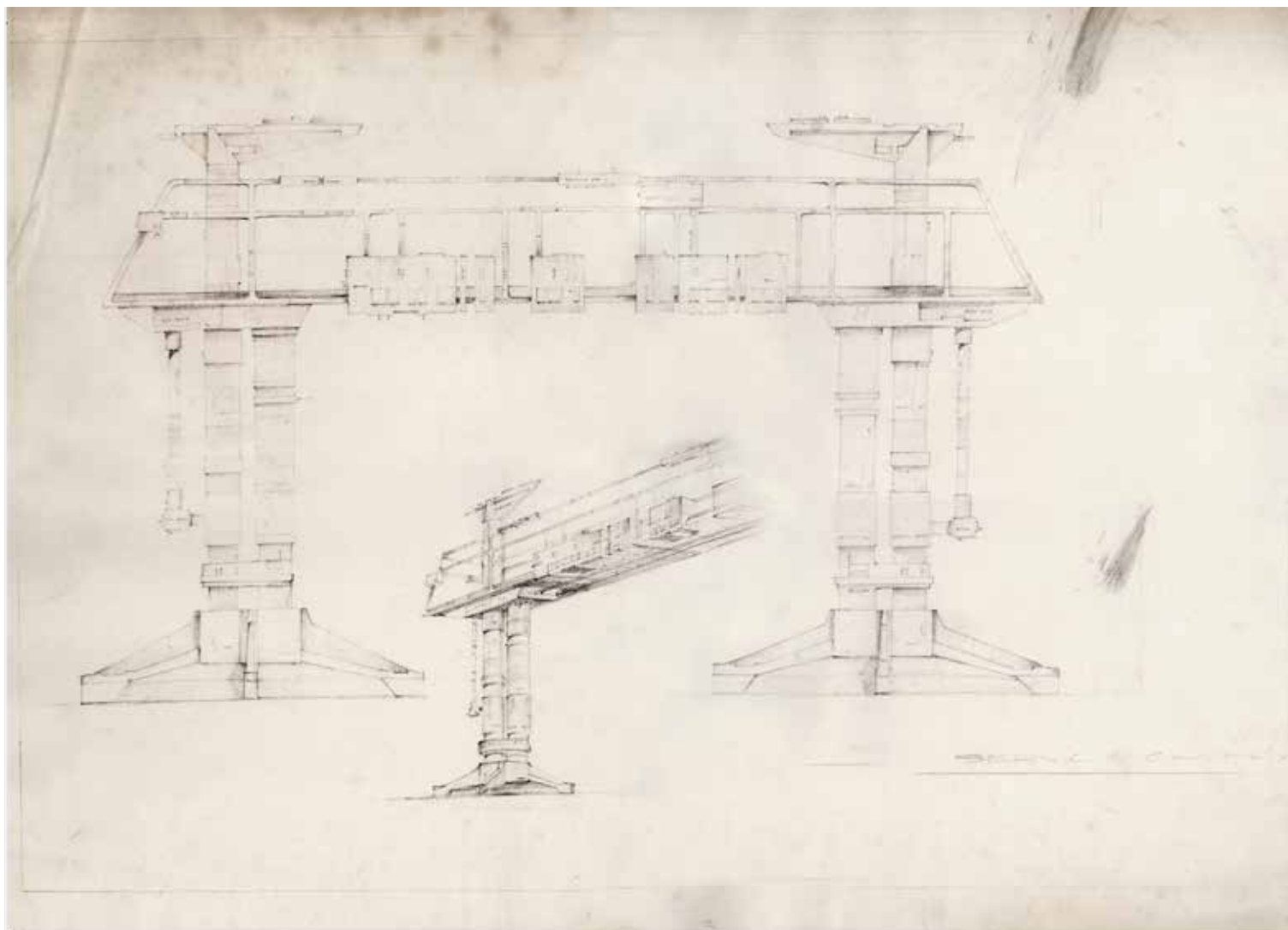

4.1.1. Estimates represent Prop Store's guide to Bidders and do not give any indication or representation of actual values or likely bids. Estimates do not include any Buyer's Premium or VAT where applicable.

4.1.2. Prop Store reserves the right to amend its estimates from time to time

4.2. Reserve Price

4.2.1. The Reserve Price is the minimum price the Seller will accept for a Lot. The Reserve Price will not be more than the lowest estimate given by Prop Store. Prop Store may disclose or keep confidential the Reserve Price at its entire discretion.

4.3. Bidding

7.11. 7.18. 7.19. Unless otherwise agreed by Prop Store in writing, the fact that the Buyer wishes to apply for an export licence does not affect or postpone the Buyer's obligation to make payment in accordance with Prop Store's payment terms nor Prop Store's right to charge interest or storage charges on late payment. If the Buyer requests Prop Store to apply for an export licence on his or her behalf, Prop Store shall be entitled to make a charge and be paid for this service. Prop Store shall not be obliged to rescind or cancel a sale nor to refund any monies paid by the Buyer to Prop Store as a result of or related to the Buyer's failure or inability to obtain an export license.

7.20. Where Lots are not collected within 14 calendar days from the due date of payment, whether or not payment has been made, a storage fee of 3% of the Hammer Price per month shall be charged to the Buyer. If the Buyer has failed to pay the Purchase Price and the cost of shipping and handling, Prop Store, at its option may cancel the sale.

8. Use of information

8.1. Prop Store will hold all personal information provided by the Bidder at registration and the Bidder agrees and consents to such information being used by Prop Store to:

8.1.1. make available each Lot for shipping to the Buyer;

8.1.2. process the Buyer's payment;

8.1.3. contact credit reference agencies and keep records of any searches carried out on Prop Store's behalf;

8.1.4. inform the Bidder about other auctions, products and services provided by Prop Store if the Bidder chose to opt-in. Please contact Prop Store by email at enquiries@propstore.com or by phone +44 (0)1494 766485 if you wish to stop receiving these;

8.1.5. inform the Bidder about important auction updates.

9. Liability

9.1. If Prop Store fails to comply with these Conditions it is responsible for loss or damage a Buyer suffers that is a foreseeable result of Prop Store's breach or its negligence. Prop Store is not responsible for any loss or damage that is not foreseeable. Loss or damage is foreseeable if an obvious consequence of Prop Store's breach or if contemplated by the Buyer and Prop Store at the time the hammer falls on the Lot at the Auction.

9.2. Subject to condition 9.3, Prop Store's liability shall be limited to the amount actually paid for the Lot by the Buyer. Save to the extent required by law, in no event shall Prop Store be liable for incidental or consequential damages of any kind.

9.3. Prop Store does not exclude or limit its liability for:

9.3.1. death or personal liability caused by its negligence or the negligence of its employees, agents or subcontractors;

9.3.2. fraud or fraudulent misrepresentation; and

9.3.3. breach of the terms implied by sections 12, 13, 14 and 15 of the Sale of Goods Act 1979 (title, description, quality and fitness for purpose) save to the fullest extent permissible at law.

10. Terms of Guarantee of Attribution

10.1. Prop Store warrants the attribution of each Lot as stated in the title block (film title and item title) of that Lot in the Auction catalogue, subject to any revisions (which may be given in writing or online before or during the Auction at which the Lot is purchased by the Buyer); this is Prop Store's Guarantee of Attribution. Buyers should be aware that multiple examples of props and costumes are frequently used during production and it is often impossible to determine whether a specific piece has been used on-camera. Any specific on-camera usage known to Prop Store will be noted within the description, but no warranties are given by Prop Store on that description.

10.2. If a Buyer demonstrates, to Prop Store's reasonable satisfaction, that the Guarantee of Attribution is materially incorrect, the sale will be rescinded if the Lot is returned to Prop Store in the same condition in which it was at the time of sale. In order to satisfy Prop Store that the Guarantee of Attribution is materially incorrect, Prop Store reserves the right to require the Buyer to obtain, at the Buyer's expense, the opinion of two experts in the field, mutually acceptable to Prop Store and the Buyer.

10.3. In the event a sale is rescinded in accordance with condition 10.2, Prop Store shall repay to the Buyer the Purchase Price. Repayment of the Purchase Price shall be the Buyer's sole remedy for an incorrect Guarantee of Attribution, to the exclusion of all other remedies to the extent permissible at law. It is specifically understood that this will be considered the Buyer's sole remedy under this clause 10.

10.4. The Buyer expressly agrees that Prop Store shall not be liable in whole or in part, for, and the Buyer shall not be entitled to recover, any special, indirect, incidental or consequential damages including loss of profits or value of investment or opportunity cost.

10.5. Bidders are aware that description revisions may occur on some Lots, and should inquire before the Auction whether any description revisions have occurred on a given Lot and/or examine a lot before bidding on it. Prop Store will make all reasonable efforts to make description revisions readily available during the Auction.

10.6. Except as expressly provided in these Conditions Prop Store shall have no liability to the Buyer

in respect of a Lot and all and any implied warranties and conditions are excluded to the fullest extent permitted by law.

11. Intellectual property rights

11.1. The copyright in all images, illustrations and written material produced by or for Prop Store relating to a Lot (including the contents of the Auction catalogue), is and shall remain at all times the property of Prop Store and shall not be used by the Buyer, nor by anyone else, without Prop Store's written consent. Prop Store and the Seller make no representation or warranty that the Buyer of a Lot will acquire any copyright or other reproduction rights in it.

11.2. In the catalogue descriptions, Prop Store takes steps to identify and provide provenance for Lots offered at auction.
